Union GOLD checking requires a \$5.00 monthly maintenance fee.

How To:

Our website offers many unique features to help you manage, budget, and protect your money. One of those features is the mobile banking alerts. This feature gives you the ability to receive alerts via email or text message based on what is most important to you. Once you are signed onto your home banking go to the alerts link on the left hand side of the screen. Once that is selected it will give you the option to set up as many different alerts as you would like. These alerts include:

- Balance alert
You can set your alert to notify you if your account reaches a certain balance
- Transaction alert
You can set your alert to notify you if a transaction takes place on your account
- Check # alert
You can set your alert to notify you when a specific check number clears your account
- Loan Payment due
You can set your alert to notify you when your loan payments are due

Once you have selected the alert you will have the option to personalize the message you receive. For example if your balance alert is set to notify you when your account gets to \$100.00 your message could say "Time to make a deposit"

The next screen is when you decide if you want to receive the alert via email or text. Once that is complete the alert is added and will notify you going forward.
